

APPROPRIATION ORDINANCE NO. 1997-4

BE IT ENACTED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS: AN APPROPRIATION ORDINANCE NO. 1997-4 TO AMEND A PORTION OF ORDINANCE NO. 1997-1.

WHEREAS, IT IS NECESSARY TO AMEND THE ORDINANCE ESTABLISHING THE SALARIES OF CERTAIN CITY EMPLOYEES.

NOW, THEREFORE, BE IT ORDAINED AND EXECUTED BY THE CITY COUNCIL OF THE CITY OF OZARK, ARKANSAS:

That Ordinance No. 1997-1 is hereby amended to reflect the following changes effective April 1, 1997:

SECTION 1. The salaries of city employees shall be:

City Inspector	448.33 monthly
Code Enforcement Officer	7.50 hourly

SECTION 2.

If any provision of this Ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect with the invalid provisions or applications and to this end, the provisions of this Ordinance are declared to be severable.

SECTION 3.

For the purpose of this Ordinance, and to maintain the fiscal integrity of the city of Ozark, Arkansas, the city reserves unto itself the right to impose constraints or restrictions upon the expenditure of funds within this measure and should this necessity arise.

SECTION 4.

This Ordinance shall affect no provision of City of Ozark Ordinance No. 1997-1 except as provided herein.

SECTION 5.

It is hereby found and declared by the Ozark City Council that an emergency exists requiring the immediate passage of this Ordinance. This Ordinance shall be in full force and effect from and after its passage.

Ralph McKinney has informed me that as of April 1 he would like to give up the code enforcement portion of his job but continue as city inspector. His salary would be the same as last year, to which he has agreed. (\$448 per month plus \$250 per month mileage) I am recommending that we hire William Schaffer for code enforcement at \$7.50 per hour and \$.31 per mile. Ralph this past month drew nearly \$1600 in salary and expenses. Based on that figure it would come to over \$19,000 per year and we have only \$13,000 budgeted. Thus I recommend we budget \$6300 for Ralph for the next nine months plus \$6000 in salary and mileage for William.
