

**ORDINANCE NO. 2008-21**

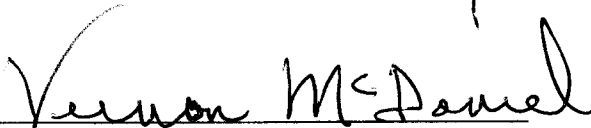

**SECTION 1: Annual Budget Adopted by Reference**

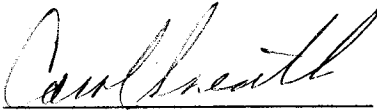
