SECTION II:

And all other provisions set out in Appropriation Ordinance No. 1996-25 shall remain in full force and effect.

SECTION III:

If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Ordinance which can be given effect with the invalid provisions or applications and to this end, the provisions of this Ordinance are declared to be severable.

SECTION IV:

For the purpose of this Ordinance and to maintain the fiscal integrity of the City of Ozark, Arkansas the City reserves unto itself the right to impose constraints or restrictions upon the expenditure of funds within this measure and should the necessity arise.

SECTION V:

It is hereby found and declared by the Ozark City Council that an emergency exists requiring the immediate passage of this Ordinance. This Ordinance shall be in full force and effect from an after its passage.
