AN ORDINANCE ACCEPTING THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF OZARK, ARKANSAS, AND MAKING SAME PART OF THE CITY OF OZARK, ASSIGNING SAME TO WARDS, DECLARING AN EMERGENCY, AND FOR OTHER PURPOSES

WHEREAS, a Petition was filed with the County Clerk of Franklin County, Arkansas by the only real estate owner(s) of the hereinafter described territory praying that said territory be annexed to, and made part of, the City of Ozark, Arkansas; and
