**WHEREAS**, Charlie Meadors is the Chairman of the Ozark Planning and Zoning Commission; and,

**WHEREAS**, the City of Ozark has determined it is in the City's best interest to continue to conduct business with Meadors Hardware, as it has in the past, and,
